PCCI-QC RECEIVES THE MOST OUTSTANDING CHAMBER AWARD - NCR



Every year the Philippine Chamber of Commerce (PCCI) embarks on a search for a recipient of Chamber Award (MOCA). PCCI-QC is not a stranger to the MOCA. It was declared as the Most Outstanding Chamber in the Philippines for the years 2000, 2002 and 2004. After three successive awards it was installed as a Hall of Fame Awardee in 2004. In the next fifteen years PCCI-QC went through a process of organizational rejuvenation resulting in a concerted effort to re-establish its credentials as an active chamber in NCR.

In 2019, under the watch of President Sarah Delaroya-Mateo and a motivated Board of Trustees led by its Chairman Pax Maghacot and Chairman Emeritus Dr. Carl E. Balita, PCCI-QC flexed its muscles to vie for the MOCA again by providing empirical evidence of its unassailable performance in three major criteria, to wit: Leadership and Dynamism, Delivery of Services to Members and Participation in PCCI National Area, Regional and Inter-Chamber Activities. After due diligence PCCI recognized the primacy of PCCI-QC in all three criteria, declaring the worthy recipient of the MOCA-NCR.

On October 17, 2019, at the 45th Philippine Business Conference, PCCI and President Rodrigo Duterte conferred on PCCI-QC the Most Outstanding Chamber Award-NCR. The MOCA celebrates the synergy of the diligent officers and members of the PCCI-QC. Is President Sarah dreaming of making this award a threeppeat, and be a hall of fame awardee one more time? With the updated vision and mission statements, plus the newly adopted-defined PCCI-QC Core Values, that dream is not an impossible one.

45TH PHILIPPINE BUSINESS CONFERENCE

The Philippine Chamber of Commerce and Industry (PCCI), the largest business organization in the Philippines, successfully held their 45th Philippine Business Conference and Expo (PBC&E) on October 16 - 17 at the Manila Hotel. The PBC&E is an annual two-day business summit that provides the collaborative venue for policymakers and industry captains to meet and exchange ideas on current issues and business opportunities. This year's theme, "Enabling Business in a Digital Economy", brings into focus new business models that are being leveraged not only by emerging organizations but also by traditional entities, which view them either as complementary to well-established models or as potential replacements of their core businesses.

The 45th PBC&E navigated the opportunities on digital platforms which are expanding across economies, reshaping the business models of a wide range of industries, from finance and healthcare to media and retail, while creating fundamentally new divisions of public and private responsibility. The Conference consistently enticed over a thousand business executives and entrepreneurs from Metro Manila and from the regions. The nation's key cabinet secretaries, ambassadors, trade attaches, consuls-general, foreign chambers of commerce and other members of the international community are always in attendance in the PBC. Business delegations from PCCI partner chambers worldwide were also participated to converge in Manila this October to network and look more closely at the potentials of the Philippine economy.

His Excellency President Rodrigo R. Duterte and Honorable Vice President Maria Leonor G. Robredo have likewise been there to address the Philippine business sector.

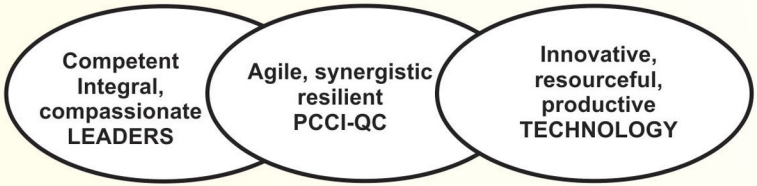
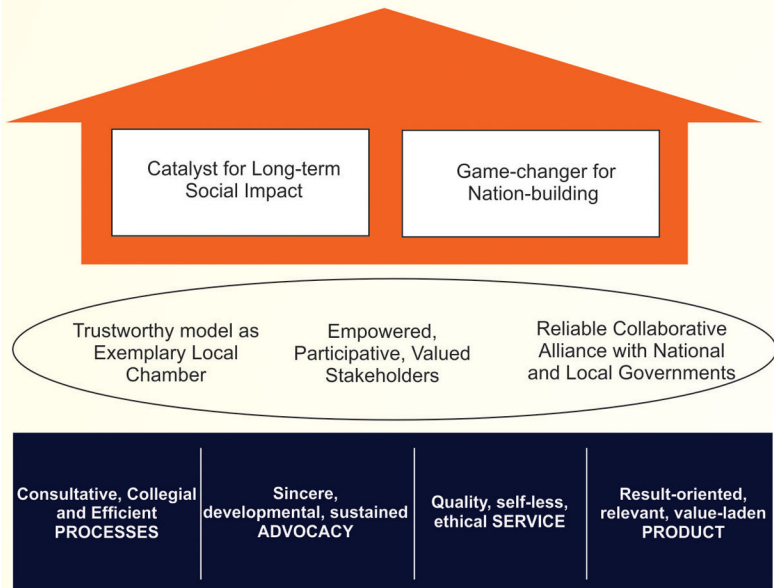

NOTES FROM THE PRESIDENT

I begin these Notes on an ebullient and congratulatory mood.

The fountain head of this feeling is plain to see. At the 45th edition of Philippine Business Conference (PBC), a date marked red in the calendar of Filipino businesses, the Philippine Chamber of Commerce and Industry-Quezon City was adjudged the Most Outstanding Chamber Award-NCR, an honor that belongs to all of our members. This rare achievement justifies and rewards the tireless efforts of PCCI-QC officials and members to elevate the organization to a stratum where the best PCCI Chambers in the country now belong. We are in a constellation of stars!

This Award, without doubt, was the culmination of our members' and officials' collaboration and work synergy during the past year. Prior to the 45th PBC we immersed ourselves in multiple Chamber-related work, one of which was the successful conduct of the Joint Business Meeting between the PCCI-QC, the Pampanga Chamber of Commerce & Industry, and PCCI-Oriental Mindoro on 30 September. During the Joint Business Meeting, we signed two Sisterhood Agreements.

For this Award, congratulations to all of us! As your PCCI-QC President I received the beautiful trophy at the PBC personally handed to me by President Rodrigo R. Duterte and DTI Secretary Ramon Lopez. On the trophy the name of the PCCI-QC is etched for posterity, and we are enormously proud of that. PCCI President Ma. Alegria Sibal Limjoco, PCCI Chairman George Barcelon, PA Joey Concepcion and other business leaders and members from PCCI local chambers witnessed the momentous occasion.

Despite our busy schedule, we continued to hold our regular Board of Trustees Meetings, General Membership Meetings (GMM) with Learning Sessions and fellowships to keep track of our progress. We participated in a brainstorming session with the QC Investment Affairs Office for the inaugural QC Investors Summit to be held on May 14, 2020. Also, were appointed as a member of the Search Committee for the President of the QC University President.

In October 14 PCCI-QC participated in a most-awaited event: the 29th Trade Mission to the Philippines of the Filipino Chamber of Commerce of Hawaii (FCCH), which occurred on 14 October. The FCCH trade mission was in partnership with the Philippine Consulate General in Honolulu and the State of Hawaii. During the mission, we entered into a sister-chamber alliance with the FCCH.

The year 2019 will be known as the birthyear of the QC Business Conference. Because in a historic collaborative undertaking, the PCCI-QC, the Quezon City Association of Filipino-Chinese Businessmen, Inc. (QCAFBI) and the Local Government of Quezon City conducted the 1st Quezon City Business Conference on November 26, 2019 at the Novotel Hotel, Cubao, Quezon City. Holding this conference was the idea of Mayor Josefina "Joy" Belmonte to finetune the vision and priorities of business in the City. The conference theme, "Quality City, Quality Business for the ASEAN and the World". The objective of the conference is to showcase the productively cooperative synergy that exist between the City Government and its thriving business community which in turn sustain its continuing economic progress. The Plenary discussions will delve on business excellence and inclusiveness, the role of effective and transparent governance in a Quality City and the integration of inclusive business and smart city in a globally competitive setting that is continually disrupted by advances in technologies. The key personalities of the conference were, PCCI-QC President Sarah Deloraya-Mateo, QCAFBI President Joseph Lim Bon-Huan, FFCCCI President Dr. Henry Lim Bon Liong, ECOP President & PhilExport President Mr. Sergio Ortiz, Mayor Joy Belmonte, Vice-Mayor Gian Sotto, DTI Undersecretary Rowel Barba, and Presidential Adviser for Entrepreneurship Joey Concepcion. But the stars of the conference were the over four hundred participants, seventy five percent (75%) of whom stayed up the last session. During the conference, another signing of Chamber Sisterhood Agreements, this time with Mandaue Chamber of Commerce and Industry, Metro Dagupan Chamber of Commerce and Industry, and PCCI Tacloban-Leyte, Inc.

Moreover, in November, we participated in the American Chamber and Philippine Chamber Conference in Chicago, USA, The 2019 FPACC National Conference in Chicago seeks to bring Filipino business leaders to share entrepreneurial expertise with the Theme: "Game Changers in a global Business World" and in the San Francisco California 46th Forum by the Bay brought together various sectors from Silicon Valley as well as Tech firms and digital leaders talked on "Digital Transformations-in Leadership, Management, Education, Women, FinTech, , Health, Security and Ag Tech"

However, among all these important events, I consider our Strategic Planning activity on 16 December one of the most consequential highlights of the year. 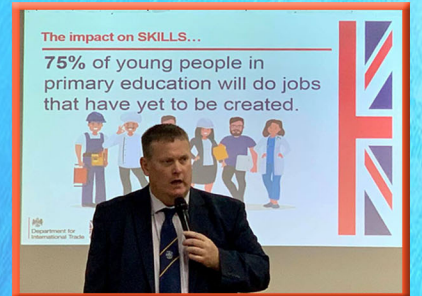
